#### **COURSE OBJECTIVE**

The goal of this course is to provide students with an introduction to finance and develop an understanding of the key concepts used in the business world.

This course provides an overview of financial management and the financial system. The goal is to equip students with a basic understanding of how financial decisions are made. Students will learn fundamental finance concepts and tools, and how they are applied in practice. The course will lay a foundation for more advanced finance courses that students will subsequently take. Topics include the time value of money, capital budgeting, risk and return trade-off, and security valuation.

#### TESTS & FINAL EXAM

There will be 2 term tests will be worth 25% each and a final exam worth 40% of your final grade. They will cover material from the textbook, readings, lectures, tutorials, and class discussions. The midterm and final exams will be written in person. The final exam for the course will be **cumulative**.

Students are required to bring their own calculator for the exams. Standard scientific calculator will be sufficient where the use of financial calculator is optional.

If a student files a successful MSAF for missing the midterm, the final exam weight will include the weight of the midterm exam. The final exam will be comprehensive and will cover the entire course.
