#### **COURSE DESCRIPTION**

International finance is one of the growing areas of the finance and economics curricula. Today's financial marketplace is truly global. No students of economics or finance can fully understand current development without some background in international finance. The subject matter of international finance is concerned with the monetary and macroeconomic relations between countries. The course examines main issues in international finance, such as the balance of payments, foreign exchange rates and foreign exchange markets, foreign exchange rate determination, international party conditions, foreign exchange risk and exposure, and international capital flows.

This course is taught primarily through lectures, readings, in-class discussions, and assignments. Please note that all the topics discussed in lecture are not always covered in the textbook. In these cases, I urge you to follow the lecture notes closely and complete all assigned readings. I strongly recommend that you read the required textbook, assigned readings, and lecture notes carefully.

- Appreciate the financial challenges and opportunities encountered by multinational corporations;
- Understand the economic determinants of foreign exchange rate and the role of the central bank in the foreign exchange and money markets;
- Recognize the relations among interest rate, inflation rate, and foreign exchange rate in the spot and futures markets;
- Measure and manage accounting and economic foreign exchange exposures;
- Understand the economics and decision factors in international financing and investments.

Students are encouraged to keep themselves up-to-date with current issues in international finance, as they may be discussed in class when appropriate. Students are also advised to practice on selected end-of-chapter questions and problems suggested by the instructor.

#### **CLASS FORMAT**

This is an in-person 3-hour lectures, twice a each week. The three hours will consist of lectures, related discussion, and consideration of applicable market examples of the concepts covered. A short break at a convenient point in the discussion will be taken to meet personal needs.

#### **COURSE EVALUATION**

Learning in this course results primarily from in-class discussion and participation of comprehensive business cases as well as out-of-class analysis. The balance of the learning results from the lectures on strategic concepts, from related readings, and from researching your presentations, cases, assignments, simulation decisions and projects. Work will be evaluated on an individual and group basis as shown below. For group work, all group members will share the same grade. Your final grade will be calculated as follows:

The questions in the mid-term and final exams are closely related to the lectures and the textbook. The purpose of the exams is twofold: to enhance your understanding of fundamental theories and concepts, and to encourage you to apply the theories to the real world. Therefore, you may expect application questions as well as theory or technical questions in exams. For application questions, you need to apply the knowledge of finance theories that you have learned in class to particular issues in the real world.

Each assignment may be completed in groups of up to 4 students. Due dates for the assignments are found in the Course Schedule.

#### Mid-Term and Final Exam

Mid-term exam is a timed exam, consisting of multiple-choice questions, numerical questions, short answers, and/or short essays.

Final exam will be cumulative and to be completed individually. It is a timed exam, consisting of multiple-choice questions, numerical questions, short answers, and/or short essays.

#### LATE ASSIGNMENTS

Due dates are clearly indicated in the course schedule. Please plan accordingly. Please also review the University's policy on requesting relief for missed academic work below.

Otherwise, a late assignment will attract a 15% penalty for each 24 hours after the due date. Assignments handed-in three (3) or more days late without a pre-determined arrangement will be awarded a mark of zero.

#### COMMUNICATION AND FEEDBACK

#### GENERATIVE AI

Some use of Generative AI is permitted for the bank project analysis. Students may find its use helpful to augment their understanding and interpretation of trend data. However, ensure that the responses generated make sense and assist your analysis!

Any use of Generative AI must be referenced and cited following citation instructions given in the syllabus. Use of generative AI outside assessment guidelines or without citation will constitute academic dishonesty. It is the student's responsibility to be clear on the limitations for use for each assessment and to be clear on the expectations for citation and reference and to do so appropriately.

#### ACADEMIC INTEGRITY

The following illustrates only three forms of academic dishonesty:

#### **AUTHENTICITY/PLAGIARISM DETECTION**

**Some courses may** use a web-based service (Turnitin.com) to reveal authenticity and ownership of student submitted work. For courses using such software, students will be expected to submit their work electronically either directly to Turnitin.com or via an online learning platform (e.g. Avenue to Learn, etc.) using plagiarism detection (a service supported by Turnitin.com) so it can be checked for academic dishonesty.

Students who do not wish their work to be submitted through the plagiarism detection software must inform the Instructor before the assignment is due. No penalty will be assigned to a student who does not submit work to the plagiarism detection software. **All submitted work is subject to normal verification that standards of academic integrity have been upheld** (e.g., on-line search, other software, etc.).
