

CLASS FORMAT

- The 1h tutorials on Wednesdays, Thursdays, and Fridays will be used as opportunities to practice solving problems from the weekly content, further explore and analyze weekly cases, introduce concepts or tools for assignments, or to answer questions arising from material.
- Presentation slides will be posted on Avenue weekly.
- Pearson MyLab MIS can be used to study assigned weekly chapters and use complete practice exercises to assess their understanding of the chapter materials.
- Weekly quizzes will be posted on Avenue. The start date for taking the content quizzes is Mondays at 9 am and the due date is Fridays at 11 pm. Students are encouraged to read the assigned chapters and material posted on Avenue before taking the content quizzes.
- Top Hat will be used for in-class assessment and to help you ask questions.

COURSE DELIVERABLES

Exams

There will be two written exams: (1) a midterm and (2) a final exam.

Both exams cover concepts from *both* lectures and assigned readings, and both are closed book.

- Midterm Exam:**

Reflection Assignment: Artificial Intelligence, Sustainability, and Ethics

The purpose of this assignment is to invite students to engage with the social, environmental, and ethical implications of artificial intelligence in contexts that are relevant to business. Drawing on course concepts and contemporary examples, the assignment develops ethical awareness, critical thinking, and responsible decision-making skills relevant to future business leaders and managers. This assignment must be completed individually to ensure that learning outcomes are achieved

independently. Group work is not permitted; collaborative submissions will be penalized by dividing the final grade by the number of individuals involved. Submissions containing copied material will receive a grade of zero and may be reviewed under the University's Academic Dishonesty policy (see section below).

Hands-on Assignment 1

This assignment is designed to support key course learning outcomes related to business data management and information systems. By completing this assignment, students will demonstrate the ability to design and implement a basic Database Management System (DBMS). Students will apply foundational database concepts by creating structured tables and developing queries. This assignment must be completed individually to ensure that learning outcomes are achieved independently. Group work is not permitted; collaborative submissions will be penalized by dividing the final grade by the number of individuals involved. Submissions containing copied material will receive a grade of zero and may be reviewed under the University's Academic Dishonesty policy (see section below).

Hands-on Assignment 2

This assignment has been devised to explore business intelligence and data analysis using software such as Microsoft Excel and Microsoft Power BI. Details of the assignment will be described in tutorial and released on Avenue. The assignment is expected to be completed individually. Work done in groups will be penalized by dividing the grade for this assignment by the number of members in the group. Work that is copied will be given a grade of zero and be scrutinized for Academic Dishonesty (see section below). All answers to assignments must be uploaded to Avenue account, as per instruction provided on the assignments.

LATE ASSIGNMENTS

- Weekly quizzes must be completed by the due date/time or will receive a grade of zero.
- Assignments will be accepted after the due date, but **a late penalty will apply where 20% will be deducted off the assignment for each late day (5 pm cutoff)**. It is each student's responsibility to submit the assignment in advance of the deadline. Note that work-in-progress for the hands-on assignment can be uploaded to AVENUE – the last version uploaded will be marked and if new versions are uploaded after the deadline, they will incur the penalty above.

COMMUNICATION AND FEEDBACK
